ABSTRAK

Tuberkulosis (TB) adalah penyakit menular yang menyerang paru dan organ lainnya seperti kelenjar, tulang, kulit disebabkan oleh *mycobacterium tuberculosis*. Tuberkulosis merupakan salah satu penyumbang kematian terbanyak di dunia. Setiap tahun angka kejadian TB terus meningkat. Fenomena yang ditemukan di RSUD Kabupaten Bintan perawat yang bertanggung jawab dalam program TB di Rumah Sakit didapatkan tingkat kepatuhan sekitar 75% dari total penderita 34 orang dan diketahui selama ini petugas hanya memberikan obat yang akan dikonsumsi secara teratur sesuai dengan yang dianjurkan tanpa disertai pesan-pesan lain terkait dengan kepatuhan dan kesembuhan dari penyakit yang diderita. Penelitian ini bertujuan untuk hubungan peran perawat edukator dengan kepatuhan pasien TB paru dalam pengobatan di RSUD Kabupaten Bintan Tahun 2022. Rancangan penelitian ini adalah deskriptif kuantitatif dengan pendekatan *cross sectional*. Sampel dalam penelitian ini adalah penderita TB Paru yang berobat di RSUD Kabupaten yang berjumlah 34 orang dan data dianalisa menggunakan uji *chi square*. Hasil diketahui uji statistik *chi-square* didapatkan nilai *p value* $0,010 \leq 0,05$ berarti ada perbedaan proporsi kepatuhan pasien dalam pengobatan yang patuh dengan peran perawat *edukator* baik, artinya H_0 ditolak dan H_a diterima. Kesimpulannya adalah ada hubungan peran perawat edukator dengan kepatuhan pasien TB paru dalam pengobatan di RSUD Kabupaten Bintan Tahun 2022. Saran bagi pelayanan keperawatan dapat dijadikan masukan bahan pertimbangan rumah sakit untuk digunakan dalam merancang kebijakan pelayanan keperawatan dengan menentukan standar operasional peran perawat sebagai edukator melalui inovasi, mengadakan seminar di lingkungan internal rumah sakit dengan mendatangkan ahli-ahli keperawatan bagi perawat khususnya untuk meningkatkan perannya sebagai edukator

*The Relationship of the Role of Educator Nurses with Pulmonary TB Patient
Compliance in Treatment at the Bintan District Hospital in 2022*

ABSTRACT

Tuberculosis (TB) is an infectious disease that attacks the lungs and other organs such as glands, bones, and skin caused by Mycobacterium tuberculosis. Tuberculosis is one of the biggest contributors to death in the world. Every year the incidence of TB continues to increase. The phenomenon found in the Bintan District Hospital, the nurse who is responsible for the TB program at the hospital, obtained a compliance rate of around 75% of the total 34 patients and it is known that so far the officers only give drugs that will be consumed regularly as recommended without any messages. others related to compliance and recovery from illness. This study aims to determine the relationship between the role of the educator nurse and the compliance of pulmonary TB patients in treatment at the Bintan District Hospital in 2022. The design of this study was descriptive quantitative with a cross-sectional approach. The sample in this study were patients with pulmonary TB who were treated at the District Hospital, amounting to 34 people and the data were analyzed using the chi-square test. The results showed that the chi-square statistical test obtained a p-value of $0.010 \leq 0.05$, which means that there is a difference in the proportion of patient compliance in obedient treatment with the role of a good nurse educator, meaning H_0 is rejected and H_a is accepted. The conclusion is that there is a relationship between the role of nurse educators with pulmonary TB patient compliance in treatment at the Bintan District Hospital in 2022. Suggestions for nursing services can be used as input for hospital considerations to be used in designing nursing service policies by determining operational standards for the role of nurses as educators through innovation, holding seminars in the internal environment of the hospital by bringing in nursing experts for nurses in particular to increase their role as educators
